

Law No. 163 of 2010
Second Amendment Instructions to the Instructions for Supporting Arabic Research
No. (51) of 1992

Based on the provisions of Paragraph (2) of Article (47) of the Law of the Ministry of Higher Education and Scientific Research No. (40) of 1988, we have issued the following instructions:

Article 1

The text of Article (4) of the Instructions for Supporting Scientific Research No. (51) of 1992 is repealed and replaced with the following:

Article 2

1. The specialized committees in the college or institute shall evaluate the research through experts, each of whom shall receive a reward of (100,000) one hundred thousand dinars.
2. Researchers shall be granted research support fees as follows:
 - (500,000) five hundred thousand dinars for original applied research.
 - (400,000) four hundred thousand dinars for valuable applied research.
 - (500,000) five hundred thousand dinars for original research.
 - (300,000) three hundred thousand dinars for valuable research.
 - (200,000) two hundred thousand dinars for useful research.

Article 3

The text of Article (5) of the instructions is repealed and replaced with the following:

- **Article 5:** A reward of (1,000,000) one million dinars shall be granted for each registered patent.

Article 4

The text of Paragraphs (1) and (2) of Article (8) of the instructions is repealed and replaced with the following:

1. The university or institution shall bear (50%) fifty percent of the total printing cost.
2. A reward of (1,000) one thousand dinars per page shall be allocated, not exceeding (250,000) two hundred fifty thousand dinars, for each expert hired by the university or institution to assess the value and eligibility of the publication for support, regardless of whether the publication is accepted or rejected.

Article 5

The text of Paragraphs (1) and (2) of Article (15) of the instructions is repealed and replaced with the following:

- **Article 15:** Authors' rewards shall be distributed as follows:

1. The author of textbooks, supplementary books, references, and sources shall receive a reward of (1,000,000) one million dinars if the work is classified as original.
2. A payment of (1,000) one thousand dinars per page, calculated according to Article (14) of the instructions, shall be made for textbooks, references, and sources, provided that the total does not exceed (250,000) two hundred fifty thousand dinars.

Article 6

The text of Article (16) of the instructions is repealed and replaced with the following:

- **Article 16:** The books mentioned in Article (15) of these instructions shall be subject to scientific and linguistic evaluation and review. The scientific reviewer shall receive a fee of (1,000) one thousand dinars per page, not exceeding (250,000) two hundred fifty thousand dinars in total. The linguistic reviewer shall receive (250) two hundred fifty dinars per page, and linguistic accuracy shall be a condition for acceptance.

Article 7

The text of Paragraphs (1) and (2) of Article (18) of the instructions is repealed and replaced with the following:

1. A reward of (2,000) two thousand dinars per page, each consisting of (25) twenty-five lines with an average of (10) ten words per line, shall be granted for textbooks, supplementary books, references, and sources. This calculation is based on foreign books.
2. The expert assigned to the scientific or linguistic evaluation shall receive the reward specified in Article (16) of the instructions.

Article 8

These instructions shall be enforced from the date of their publication in the official gazette.
